#### RECENT ACTIVITIES

#### **Sir Maurice Bathurst**

Members will be saddened to hear that Sir Maurice Bathurst, former Vice President of the Institute, died recently. He was in the FCO legal service and held many judicial and other appointments. He was Vice President under Lord Denning from 1986 onwards, only resigning from the position some three years ago. At the Grotius dinner on 11 November 2004, Lord Bingham paid a generous tribute to Sir Maurice and mentioned how active a role he played particularly in the interregnum between Kenneth Simmonds and Lady Fox's appointment as Director of the Institute.

#### Peter Carter

We are also sorry to report that Peter Carter, who gave distinguished service as a member of the Board of Editors of the *Quarterly* for exactly 40 years, died on 16 September 2004, at the age of 83. His acute and intellectually rigorous assessments ensured that the quality of the articles in the *Quarterly* remained high, and were a significant contribution to the standing of the journal. A fuller appreciation of his life appears in the latest volume of the *Quarterly* (volume 54 part 1, January 2005).

### **Death Penalty in Africa Project**

As part of the Institute's ongoing 'Legal Tools for Commonwealth Africa' project, funded by the European Commission and the Nuffield foundation, the Institute and the Bar Human Rights Committee organized a successful workshop on lawyers' advocacy in Zomba, Malawi, in October 2004. Attended by lawyers from all 13 countries in the project, it provided training on the strategic uses of the legal materials assembled by the Project and fostered the further development of the network of death penalty litigators.

A conference on human rights and the death penalty in Africa was held on 5 November 2004, at which African human rights lawyers shared their various experiences, analysed the major lapses of existing legal systems and charted a way forward, taking advantage of international instruments and the sharing of legal tactics. Topics covered included developments in international law and the trend towards abolition, the giant leap that the Caribbean has made concerning the death penalty, the use of the death penalty in the Congo as a fight against political opponents, Islamic law in Sudan, the serious human rights abuses in Cameroon, and the practical difficulties of human rights work in Zimbabwe.

### The Regulation Forum

Professor Cees van Dam, Director of the Regulation Forum and Professorial Fellow at the Institute, has succeeded in getting two funded research projects, one by the Dutch Ministry of Justice and one by the European Commission.

The project for the Dutch Ministry of Justice concerns the liability risks for inadequate supervision or enforcement by public bodies with a supervisory function in the area of health and safety and in the area of economic regulation. The research report needs to make clear how this risk can be limited or eliminated and what, in this respect, the best rules for liability of supervisors would be. The conclusions of the project will be based, inter alia, on French, Italian, German, Belgian, and UK law as well as on community law and the relevant case law of the European Court of Human Rights.

In November 2004 the European Commission selected the Institute's bid for the award of a project on Unfair Commercial Practices in the new EU Member States. The project aims to analyse the existing national rules, including case law, on unfair commercial practices between business and consumers in the New Member States and the possible resulting internal market barriers. For this purpose a working group, consisting of academics and practitioners in the new Member States, has been set up. The members of this Working Group will write the national reports on the basis of a questionnaire; these reports will be the basis for the general report to be written by the British Institute.
