# CONFERENCE OVERVIEW

---

As the number of international law norms increases, so does its fragmentation. Cases in which the same issue is governed by overlapping and sometimes conflicting treaty regimes become increasingly common. How do investors and State reconcile their rights and obligations under investment, EU, environmental, human rights, anti-corruption, trade, and other treaty regimes? Are tribunals obliged to take into accounts rights and obligations of parties to investor-State disputes even if none of the parties pleads it? How to reconcile conflicting treaty rules taking into account the legitimate expectations of investors and the rights of States to regulate?

These and other questions will be addressed during a one-day conference hosted by Investment Treaty Forum, which will take place in the hybrid format (in-person and online) at the British Institute of International and Comparative Law.

Dr Federico Ortino is Professor of International Economic Law at King's College London. He is a member of the ILA Committee on the Rule of Law and International Investment Law; founding Committee Member of the Society of International Economic Law; consultative member of the Investment Treaty Forum; editorial board member of the Journal of International Economic Law; Yearbook on International Investment Law and Policy, Journal of International Dispute Settlement, Journal of World Investment and Trade. He is a Consultant to Clifford Chance.

Previously, he was co-rapporteur to the ILA Committee on the Law of Foreign Investment; Director, Investment Treaty Forum, British Institute of International and Comparative Law in London (2005-2007); Adjunct Professor at the Universities of Florence and Trento (2002-2007); Emile Noël Fellow and Fulbright Scholar at the NYU Jean Monnet Center in New York (2004); Legal Officer at the United Nations Conference on Trade and Development, Division on Investment and Enterprises (2003). He is a qualified attorney in Italy and in the state of New York. He holds: LLB, University of Florence; LLM, Georgetown University Law Center; PhD, European University Institute.





### **Professor Joost Pauwelyn**

#### **Graduate Institute of International and Development Studies**

Joost Pauwelyn is Professor of International Law at the Graduate Institute of International and Development Studies in Geneva, Switzerland and Co-Director of the Institute's Centre for Trade and Economic Integration (CTEI). He is also the Murase Visiting Professor of Law at Georgetown University Law Center (since 2014). Previously he was Professor of Law at Duke University (2002-2007). He has also taught at Neuchâtel, Columbia, NYU, Stanford and Harvard law schools and worked as legal adviser for the WTO Secretariat (1996-2002). From 2007 to 2014, he was Senior Advisor with the law firm of King & Spalding.

Joost specializes in international economic law, in particular trade law and investment law, and its relationship to public international law. He also frequently advises governments and industry in WTO dispute settlement and investment arbitration and is a leading force behind the global [www.tradelab.org](http://www.tradelab.org) network of legal clinics on international economic law. From 2015 to 2020, Joost was the Co-Editor in Chief of the Journal of International Economic Law. In late 2020, Professor Pauwelyn was appointed to the WTO's multi-party interim appeal arrangement (MPIA, nominated by the EU).



### **Dr. Claudia Salgado Levy**

Dr. Claudia Salgado Levy is the National Director of International Affairs and Arbitration at the Attorney General Office of Ecuador. She has extensive experience working on international arbitration procedures (ICSID, UNCITRAL, ICC) as well as in proceedings before the Court of Justice of the Andean Community and the Inter-American Court of Human Rights. # Online Course International Investment Law and Dispute Resolution

## Overview

This course covers the history and the rationale of protection of foreign direct investments, applicable law, the key principles of international investment law and investor-state dispute settlement (ISDS). Participants will develop their own critical appreciation of international investment law and will cover the nature of international investment law, the main substantive and procedural principles, dispute resolution mechanisms and the current professional criticisms of the system. Total guided learning time is approximately 18 hours.
