BIICL: 60 years on

2018 marks the 60th anniversary of the British Institute of International and Comparative Law (BIICL) which was established in 1958 following the merger of the Society of Comparative Legislation (founded in 1895) and the Grotius Society (founded in 1915). This merger created an independent research institute, unaffiliated to any university, which has become a world-leading authority on international and comparative law and the rule of law.

BIICL's research and training is making an important contribution to international security and prosperity by influencing debate, legal reform and policy making around the world. Our seminars and conferences have a wider public benefit by providing information and education about contemporary issues. Our journal, the *International and Comparative Law Quarterly*, has maintained its pre-eminence as one of the most important publications of its kind, offering practitioners and academics topical coverage on a wide range of issues.

Our core team has grown to 35 staff which is supplemented by around 30 research assistants and volunteer researchers each year. Our researchers are recognised as world experts in their fields on topics such as business and human rights, environmental law, investment treaty arbitration, competition law, collective redress, judicial appointments, access to justice, protection of education and cultural heritage, and refugee law.

Our refurbishment plans

Our location in central London allows us to engage with our key stakeholders from around the world including governments, international organisations, companies, lawyers, barristers, judges, academics, educators, journalists and NGOs. We typically organise over 70 events each year with around 4,000 attendees.

Our offices are located in a Grade II* listed building which has had no major infrastructure improvements since it was built in 1976 and is no longer fit for purpose. We need to refurbish and reconfigure the space to provide a more modern, efficient and professional working environment, and an attractive and comfortable public space for events and meetings.

In summer 2019, we shall embark on a major refurbishment of our first-floor space in Charles Clore House. This will involve reconfiguration of the offices to make best use of the space, the installation of secondary glazing, sound reduction and better air circulation, new office furniture, improved storage and contemporary décor. We also want to create a new purpose-built event space with improved disabled access and state-of-the art audio visual equipment.

It is estimated that the total cost to BIICL will be in the region of £1,500,000 (much of which relates to essential upgrading of the fabric of the building and the installation of new services). Due to prudent financial management in recent years, we are able to draw down some funds from our reserves. But in order to retain sufficient working capital, we need to raise at least £500,000 in the next 12 months.
